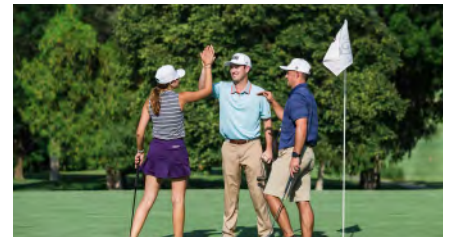

STEP 1: Establish a Corporate Holder Membership

A company must first establish a **\$500 Corporate Holder** membership, to enable corporate membership tiers for employees.

STEP 2: Employees select a Membership Tier
